- a. On or around October 9, 2019 the Board received CONFIDENTIAL from Riverbend Post-Acute Rehabilitation facility alleging that Licensee submitted false billing and treatment records for a patient he did not see or treat.
- b. As a result of CONFIDENTIAL, KSBHA CONFIDENTIAL was initiated.
- c. On November 4, 2019, a Board Investigator contacted Licensee via mail alerting him

  and requesting that he provide a complete written narrative statement concerning the

- d. On December 2, 2019, the Board Investigator sent a follow up letter to Licensee stating that the November 4, 2019, letter was returned "Return to Sender – Unclaimed – Unable to Forward." Licensee's deadline was extended to December 16, 2019 (EXHIBIT 2 – December 2, 2019 Second Contact Letter).
- e. On March 2, 2020, the Board Investigator contacted Licensee via e-mail and again reiterated the Board's request for a response and cooperation with CONFIDENTIAL (EXHIBIT 3 March 2, 2020 Third Contact Letter).

f. As a result of Licensee's failure to respond to the Board's multiple attempts at contact, the Board has been unable to complete its mission to CONFIDENTIAL protect the public.

## Applicable Law

- 5. Under K.S.A. 65-5410(a)(2), the board may suspend, revoke or limit a license or the licensee may be publicly or privately censured where the licensee has been guilty of unprofessional conduct.
- 6. K.A.R. 100-54-5(g) defines unprofessional conduct as "failing to furnish the board, its investigators, or its representatives any information legally requested by the board".
- Licensee has failed to respond to multiple requests for information regarding

## Conclusions of Law

- 8. The Board finds Licensee violated K.S.A. 65-5410(a)(2) and K.A.R. 100-54-5(g) by engaging in unprofessional conduct when he failed to respond to the Board's Notice of CONFIDENTIA letters and to its investigator's e-mail.
  - The Board has jurisdiction over Licensee as well as the subject matter of this
    proceeding and such proceeding is held in the public interest.
  - 10. Based on the facts and circumstances set forth herein, the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a) in that the use of summary proceedings does not violate any provision of law and the protection of the public interest does not require the Board to give notice and opportunity to participate to person other than Licensee.

IT IS, THEREFORE, ORDERED that Licensee's license is SUSPENDED for violating

K.S.A. 65-5410(a)(2) and K.A.R. 100-54-5(g) until such time as he contacts the Board's

investigator and provides the information required in the form of a written response to the

## General Outline of the Investigative Process

In an effort to provide a basic understanding of the investigative process and timelines, the Board has created this brief outline and description of the steps and different routes of an investigation against a licensee of the Board.

If you have any questions at any time regarding an investigation, please feel free to contact either the investigator assigned to your case or the Chief Investigator. If you are represented by an attorney during this process, your attorney may contact the investigator assigned to your case on your behalf, or the Chief Investigator.

Once a complaint is received, Disciplinary Counsel reviews the complaint and makes an initial determination: the complaint must pertain to the practice of the healing arts, and must allege facts constituting a violation of the applicable Practice Act. These two requirements are necessary to open a case for investigation. Sometimes the complaint contains insufficient information and more information may be requested of the complainant.

If the allegation in the complaint demonstrates a potential violation of an applicable Practice Act, the complaint will be used to open an investigation and it will be assigned to an investigator. The licensee and the complainant will be notified by letter:

- Licensee will receive a letter notifying them of the complaint and subsequent investigation, it will contain the investigator's contact information
- Complainant will receive a letter notifying them that an investigation has been initiated, and it will contain their investigator's contact information

If the allegation in the complaint *does not* demonstrate a potential violation of an applicable Practice Act, the complaint will be closed with no action. The complainant will be notified by letter:

- No violation: this letter states that no violation was found, and the case is closed.
- The complaint does remain in the licensee's database record.

<u>Anonymous complaints</u> – If a true anonymous complaint is received, it will be treated as every other complaint. If a violation is found, it will be thoroughly investigated. If a complaint is received and the complainant wishes to remain anonymous, the Board will do everything it can to maintain the anonymity of the complainant. Due to the legal process involved in some cases, the Board cannot guarantee explicit anonymity to all complainants.

Board investigations are required by law to be confidential, pursuant to K.S.A. 65-2898a. Therefore, during the investigation process, there are limits to what information may be released. This includes the person making the complaint, the subject of the complaint or either of their attorney.

## Initial investigation - 3 to 6 months

After a complaint is assigned for investigation, the assigned investigator will review the allegations within the complaint and determine what information and documentation to collect from the licensee, hospitals, pharmacies and any other person or entity identified as having relevant information pertaining to the

investigation. Once the investigation has been completed, it is then submitted for review by the corresponding committee, or disciplinary panel for direction. If the issue involves competency, the case may be reviewed by a panel of peers to determine whether the standard of care has been met.

## Further investigation - additional 3 to 6 months

The committee will typically review the case at one of its monthly meetings during this phase of the investigation. If the review committee or disciplinary panel identify a need for further information to support a possible violation of the licensees Practice Act, it will provide the investigator direction on what additional information is needed.

## Forward to the Board

Once the review committee or disciplinary panel has reviewed all the material gathered during the investigation and decides whether or not the evidence supports a violation of the licensee's Practice Act, the case is then forwarded to the Board. Up to an additional three months may be needed for the board to review all the material. If the Board determines the evidence supports a violation of the licensees Practice Act, the Board moves for disciplinary action against licensee.

In the event a case requires litigation, interested parties should contact the assigned attorney for information and updates. Cases requiring litigation will significantly increase the amount of time until a final action is determined.

## Notice of Proposed Disciplinary Action

The licensee receives notification of the Board's decision outlining the specific allegations and violations summarizing their basis for disciplinary action. The Board has legal authority to revoke, suspend, or limit licenses/registrations, impose fines, reprimand, require monitoring, or additional education or other remedial measures.


