**SUMMARY ORDER**

NOW ON THIS 16 day of May, 2016, this matter comes before Kathleen Selzler Lippert, Executive Director, Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A. 77-537.

Pursuant to K.S.A. 77-537, this Summary Order shall become effective as a Final Order, without further notice, if no request for hearing is made within fifteen (15) days of service.

Upon review of the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and order are made for and on behalf of the Board:

**Findings of Fact**

1. Lisa Bussell, R.T. ("Licensee") was originally issued license number 16-02737 to practice as a respiratory therapist in the State of Kansas on or about August 23, 2001. Licensee's current license designation is active, and such license was last renewed on or about March 29, 2016.
2. Licensee's last known mailing address as provided to the Board is: **Confidential**  
**Confidential** Lenexa, Kansas 66227.
3. This Summary Order incorporates herein by reference the facts as stated in the Summary Order that was filed April 15, 2013, in KSBHA Docket No. 13-HA00081.

4. The April 15, 2013, Summary Order ordered Licensee to pay the assessed civil fine, pursuant to K.S.A. 65-5510(c), in the amount of \$100.00 for her violation of the Kansas Respiratory Therapy Practice Act. The \$100.00 fine was due to be paid to the Board by May 15, 2013.

5. Furthermore, the April 15, 2013, Summary Order ordered Licensee to show completion of twelve (12) contact hours of continuing education earned between April 1, 2012, and March 30, 2013, and submit this proof of completion to the Board within thirty (30) days following the service of the September 10, 2013, Summary Order.

6. Pursuant to K.S.A. 77-542, the Summary Order notified Licensee that if a written request for a hearing was not filed within fifteen (15) days following service of the Summary Order, the Summary Order would become effective as a Final Order upon expiration of the time for requesting a hearing.

7. On or about January 15, 2015, the Summary Order became a Final Order.

8. On or about March 10, 2016, Board staff sent to Licensee a letter that notified her that she had failed to remit the aforementioned fine to the Board.

9. On or about March 29, 2016, Licensee spoke with Board staff regarding the owed fine and the submission of her completed continuing education earned between April 1, 2012, and March 30, 2013.

10. On or about April 7, 2016, Board staff attempted to contact Licensee, and left a voicemail inquiring about the aforementioned fine and continuing education completion.

11. Further, on or about April 7, 2016, Board staff sent to Licensee via e-mail and U.S. Mail, first-class postage prepaid a copy of the April 15, 2013, Summary Order.

12. Licensee failed to remit to the Board full payment of her civil fine pursuant to the

April 15, 2013, Summary Order; and this fine remains due, owing, and unpaid.

13. Additionally, Licensee failed to submit to the Board documentation evidencing completion of twelve (12) contact hours of continuing education earned between April 1, 2012, and March 30, 2013, as ordered by the April 15, 2013, Summary Order.

#### Applicable Law

8. K.S.A. 65-5510(a) states in pertinent part:

The board may deny, refuse to renew, suspend, revoke or limit a license or the licensee may be publicly or privately censured where the licensee or applicant for licensure has been guilty of unprofessional conduct which has endangered or is likely to endanger the health, welfare or safety of the public. Unprofessional conduct includes:...(4) violating any lawful order ...of the board.

#### Conclusions of Law

9. The Board has jurisdiction over Licensee as well as the subject matter of this proceeding, and such proceeding is held in the public interest.

10. The Board finds that Licensee violated K.S.A. 65-5510(a)(4) in that Licensee violated a lawful order of the Board previously issued by the Board in KSBHA Docket No. 13-HA00081.

11. Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of the law and the protection of the public interest does not require the Board to give notice and opportunity to participate to persons other than Licensee, Lisa Bussell, R.T.


**IT IS, THEREFORE, ORDERED** that Licensee is hereby **INDEFINITELY SUSPENDED** for Licensee's violations of the Respiratory Therapy Practice Act. Licensee shall

be Indefinitely Suspended until such time as she provides to the Board documentation evidencing completion of twelve (12) contact hours of continuing education earned between April 1, 2012, and March 30, 2013, and until such time as she submits to the Board full payment of her civil fine of \$100.00, as by the April 15, 2013, Summary Order in KSBHA Docket No. 13-HA00081.

**PLEASE TAKE NOTICE** that upon becoming effective as a Final Order, this document shall be deemed a public record and be reported to any reporting entities authorized to receive such disclosure.


