FINAL ORDER GRANTING LIMITED LICENSE

NOW on this 17th day of June 2011, comes before the Kansas State Board of Healing Arts (“Board”) the application of Thomas Campbell (“Applicant”) for a license to practice as an occupational therapy assistant in the State of Kansas. Applicant appears pro se. Stacy Bond, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of Ms. Bond, receiving Board Exhibits 1 and 2 into evidence, hearing the testimony of Applicant and being otherwise duly advised in the premises, the Board makes the following findings of fact, conclusions and order:

1. Applicant’s mailing address as provided to the Board is: confidential , Salina, Kansas 67401.
2. Applicant submitted to the Board an application for a license to practice as an occupational therapy assistant in the State of Kansas. Such application was deemed complete and filed with the Board on April 27, 2011.

3. In his application, Applicant disclosed that in May of 2010, he was placed on disciplinary probation by Brown Mackie College while attending the OTA Program.

4. Applicant also disclosed a criminal history which included a 1998 conviction for consumption by a minor, a 1999 DUI, a 1999 conviction for consumption by a minor, a 2006 conviction for assault known reckless to cause injury, a 2006 plea to a violation of a protection from abuse order, a 2007 conviction for disorderly conduct, a 2007 conviction for domestic violence battery and possession of drug paraphernalia, a 2007 no contest plea to violating a protection from abuse order, and a 2008 plea to reckless driving, improper turn and no seatbelt.

8. confidential in the course of preparing to engage in fieldwork during participation in the OTA Program at Brown Mackie College constitutes unprofessional conduct in violation of K.S.A. 65-5410(a)(2), as further defined by K.A.R. 100-54-5(c), in that Applicant was practicing occupational therapy without reasonable skill and safety confidential

9. Applicant's criminal history of convictions confidential and potentially violent actions constitutes unprofessional conduct in violation of K.S.A. 65-5410(a)(2), as further defined by K.A.R. 100-54-5(o), in that Applicant committed conduct likely to harm the public.

10. The evidence demonstrates that in order to ensure Applicant practices as an occupational therapy assistant with reasonable skill and safety to patients, Applicant should be granted licensure with limitations that require monitoring confidential

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant is hereby granted a license to practice as an occupational therapy assistant in Kansas and that such license is LIMITED in that Applicant shall not practice as an occupational therapy assistant unless Applicant is in compliance with the following provisions:



- g. For any period of time that Applicant is not actively practicing in Kansas, the limitation on his license will remain in effect but such period will not be counted towards reducing the limitation timeframe.
- h. The limitation is not self-terminating. Upon successful completion of three (3) years confidential , Applicant may petition the Board to request termination of the limitation on his license.

IT IS FURTHER ORDERED that the provisions of this Final Order constitute disciplinary action.

IT IS FURTHER ORDERED that the Board shall maintain jurisdiction over this matter to issue any future order(s) deemed necessary and appropriate in the circumstances.


