4. Licensee has successfully completed the conditions imposed upon him and has met all the requirements imposed by the Consent Order.


5. The Consent Order and the requirements imposed upon Licensee by such Order should be terminated effective June 4, 2008, **(Confidential)**

A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in District Court as authorized under the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 *et seq.* A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any such petition must be served upon the Board addressed to the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. A request for reconsideration is not a prerequisite to judicial review.


