FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 16th day of August, 1997, this matter comes on for consideration before the Kansas Board of Healing Arts (hereinafter "Board"), sitting as a whole in a conference hearing, the request of Stephen J. Centye, R.T., (hereinafter "Registrant") to modify the voluntary and informal agreement between himself and the Board.

Lawrence T. Buening, Jr., Executive Director, presented information before the Board. Registrant appears in person pro se.

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. Registrant was originally issued registration number 16-00325 as a respiratory therapist on August 15, 1987, which was cancelled for non-renewal on February 1, 1989.

2. Registrant's Application for Reinstatement was received by the Board on August 15, 1995, but was not deemed complete until a required photograph was received March 26, 1997.

3. Registration number 16-00325 issued to Registrant was cancelled on February 1, 1989, and reinstated effective June 27, 1997.

4. At the June 27, 1997 Board Meeting, Registrant voluntarily agreed to certain informal conditions which served as a basis for the Board approving his reinstatement of registration.

IT IS THEREFORE BY THE BOARD ORDERED as follows:

a. That the findings here and above made be and the same are made the Order of the Board.

b. That the original voluntary and informal agreement between Registrant and the Board stands as originally agreed to on June 27, 1997 and Registrant's request for modification to the original voluntary and informal agreement is DENIED.

c. That this is a Final Order and is effective upon service on the parties. Any party may, within fifteen (15) days after service file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.


