ORDER GRANTING SECOND TEMPORARY REGISTRATION

- 2. Notice of Conference Hearing setting this matter for hearing at 1:15 p.m. on February 15, 1997 was filed herein on January 31, 1997 and served on Registrant on that same date.
- 3. Registrant has applied for permanent registration as an occupational therapist, but has not passed an exam approved by the Board as required by K.S.A. 65-5406(a)(3).
- 4. Registrant was granted temporary registration number 9622773, which will expire March 15, 1997.
- 5. Pursuant to K.S.A. 65-5408(d), not more than one temporary registration shall be permitted to any one person without the majority approval of the members of the Board.
- 6. The Board finds that sufficient cause exists to grant Registrant a second temporary registration.
- 7. Upon payment of the appropriate fees, Registrant should be granted a second temporary registration to expire June 30, 1997.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

A. That upon payment of the appropriate fee, a second temporary registration be granted to registrant to expire June 30, 1997.

B. That this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
