COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about February 3, 2016, Aaron L. Cheney, D.C. (“Licensee”) entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Consent Order required Licensee to successfully complete the continuing medical education programs:

- a. The HIPAA Compliance and Documentation Guidelines course offered by Kansas Chiropractic Association; and
- b. The X-Ray Safety & Positioning for the Chiropractic Office 12-hour Certification Course offered by Dr. Ben O. Stiles, D.C., D.A.C.B.R. as a provider of continuing education by the Kansas Chiropractic Association.

2. On or about May 12, 2016, Licensee submitted to the Board documentation evidencing his successful completion of the aforementioned continuing education courses as required pursuant to the Consent Order.

3. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements of the Consent Order filed on February 3, 2016.


