ORDER DENYING THIRD TEMPORARY PERMIT

NOW on this 6th day of December, 1996, this matter comes on for conference proceedings at the request of Timmy Clark (hereafter "Permittee") to grant a third temporary permit pursuant to K.S.A. 1995 Supp. 65-2906(b)(3) and more specifically, K.A.R. 100-36-1.

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts (hereafter "Board"). Permittee did not appear.

After hearing statements from the Licensing Administrator and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

- 1) A request for a third temporary permit was submitted by Permittee, and conference hearing was set for December 6, 1996.
- 2) Permittee has applied for permanent registration as a physical therapist assistant, but has not passed an exam approved by the Board as required by K.S.A. 1995 Supp. 65-2906(b)(3).
- 3) Pursuant to K.A.R. 100-36-1, not more than two temporary permits shall be permitted to any one person without the majority approval of the members of the Board and for which good cause shall be shown.
- 4) The Board finds that insufficient cause exists to grant Permittee a third temporary permit. Permittee may reapply for a third temporary permit once the required exam has been passed,

and proof has been provided as such, and all of the requirements for permanent registration as a physical therapist assistant have been met.

IT IS THEREFORE ORDERED as follows:

- a. That Permittee's request for a third temporary permit is denied.
- b. That this is a final order and is effective upon service upon the parties. Any party may, within fifteen (15) days of service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
