SUMMARY ORDER OF CANCELLATION OF REGISTRATION

NOW, on this 8th day of April, 1994, this matter comes before Lawrence T. Buening, Jr., serving as Presiding Officer in summary proceedings. Licensee does not appear.

The Presiding Office specifies the following findings of fact, conclusions of law and reasons for actions:

1. The registration of Mary M. Clugston (hereafter "Registrant") issued by the Kansas State Board of Healing Arts (hereafter "Board") as a Respiratory Therapist in the State of Kansas expired December 31, 1993, pursuant to K.A.R. 100-55-6.

2. On or about January 15, 1994, the Board mailed Registrant a second notice that the registration had expired and provided a Notice of Proposed Cancellation of Registration that if a fully completed application for renewal, the annual renewal fee of \$30 and the additional late fee of \$5 was not received by February 1, 1994, a Conference Hearing would be held February 8, 1994 at 11:00 a.m. to consider the cancellation of the registration.

SUMMARY ORDER OF CANCELLATION OF REGISTRATION

3. On or about January 27, 1994, the Board received Registrant's application for renewal and a check numbered 584 in the sum of \$35.

4. As a result of receipt of said check and application for renewal, Registrant was issued receipt #9485736 indicating Registrant's registration in the State of Kansas had been renewed for the period of January 1, 1994 through March 31, 1995.

5. On February 25, 1994, the Board received notification from the State Treasurer that Registrant's aforementioned check had been returned not paid because of insufficient funds in the account and Registrant was advised of the return of the check.

6. On or about March 21, 1994, the Board received check #105 drawn on the City National Bank of Pittsburg in the sum of \$50 as a replacement for the previous check together with service charges. The Board has received notification from the State Treasurer that said check has also returned not paid because of insufficient funds.

7. Registrant's registration to practice as a Respiratory Therapist in the State of Kansas should be cancelled due to failure to renew as provided by K.S.A. 65-5512.

IT IS THEREFORE ORDERED that the registration of Registrant issued by the Board to practice as a Respiratory Therapist in the State of Kansas is cancelled.

SUMMARY ORDER OF CANCELLATION OF REGISTRATION

IT IS FURTHER ORDERED that Registrant is entitled to request a hearing on this Order, in writing, to the Kansas State Board of Healing Arts, 235 S. Topeka Boulevard, Topeka, Kansas 66603-3068 within five (5) days of service of this Order and if a hearing is not requested within the time and manner as stated above, this decision becomes final and effective upon the expiration of the time for requesting a hearing.


