NOW on this _____ day of March, 1997, this matter comes on before Lawrence T.

Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (hereafter "Board")

serving as Presiding Officer in summary proceedings pursuant to K.S.A. 77-537, the 96-97 license renewal to practice chiropractic in the State of Kansas filed by Paul G. Cook, D.C. (hereafter "Licensee").

The Presiding Officer specifies the following findings of fact and conclusions of law and reasons for action:

- 1. Licensee was originally issued license number 01-04227 by the Kansas State Board of Healing Arts (hereafter "Board") to practice chiropractic in the State of Kansas on August 13, 1994. Licensee last renewed his license for the 96-97 renewal period on August 1, 1996.
- 2. On or about August 1, 1996, Licensee advised the Board office that due to a misunderstanding he had not obtained the necessary continuing education hours required for license renewal and requested that he be granted a 6-month extension in which to complete his continuing education hours for the 96-97 renewal period.

3. On or about August 5, 1996, Licensee was advised by Board staff that his request for and extension to obtain the balance of his continuing education hours was granted for six months with

proof of the hours to be provided to this office by December 31, 1996.

4. On or about December 11, 1996, Licensee was sent a second notice that his

continuing education hours were due by December 31, 1996.

5. Licensee failed to provide proof of completion of the required continuing education

hours by December 31, 1996 and on February 10, 1997 a summary order of cancellation of license

was filed cancelling licensee's license.

6. Charlene K. Abbott, Licensing Administrator, advises the Presiding Officer that

following the Board's SUMMARY ORDER OF CANCELLATION OF LICENSE served upon

Licensee on February 10, 1997, Licensee on February 21, 1997, submitted via facsimile, the

required proof of continuing educational hours as required by K.A.R. 100-15-2(c).

It is therefore determined by the Presiding Officer that Licensee has submitted the evidence

necessary for renewal of his license to practice chiropractic under K.A.R. 100-15-2(c). Also, that the

SUMMARY ORDER OF CANCELLATION OF LICENSE should be set aside and Licensee's license

to practice chiropractic in the State of Kansas be renewed for the period July 1, 1996 through June

30, 1997.
