**FINAL ORDER GRANTING REQUEST FOR TERMINATION
OF MONITORING**

NOW on this 9th day of August 2013, comes before the Kansas State Board of Healing Arts ("Board") the request of Ronda Copple, R.T. ("Licensee") for termination of the monitoring requirements contained in the Consent Order filed August 19, 2008. Licensee appears in person and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-5501 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the file, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Ronda Copple, R.T. ("Licensee"), is licensed to engage in the practice of respiratory therapy in the State of Kansas, License No. 16-01917, and has been so licensed since approximately August 17, 1996.

2. Licensee's last known mailing address provided to the Board is: **CONFIDENTI** Ave., Clay Center, Kansas, 67432.

3. On or about August 19, 2008, Licensee entered into a Consent Order with the Board which imposed monitoring requirements on Licensee.

5. The terms of the Consent Order allow Licensee to petition the Board for modification or termination of the Order after a period of five (5) years.

10. On July 12, 2013, the Respondent Board filed a Response to Petition for Termination of Monitoring.



PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service, and service of a Final Order is complete upon mailing. Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order. 
