**ORDER TERMINATING STIPULATION

2. That after hearing statements of the parties, the Board is satisfied that Licensee has met the terms of the Stipulation and the conditions placed upon his license.
3. The Stipulation and Agreement and Enforcement Order filed on June 14, 1993 should be terminated.


NOW, THEREFORE, it is ordered by the Board that the findings hereinabove made be and the same are hereby made the order of the Board; that the Stipulation and Agreement and Enforcement Order filed on June 14, 1993 is hereby terminated. As provided at K.S.A.

1998 Supp. 65-4925, a Protective Order is hereby entered prohibiting disclosure of Exhibit 1 entered into evidence on February 13, 1999 relative to this matter.


