ORDER GRANTING SECOND TEMPORARY REGISTRATION

NOW on this 28th day of April, 2001, this matter comes on for conference proceedings before the full Board at the request of Darren Couts (hereafter "Applicant") to grant a second temporary registration pursuant to K.A.R. 100-69-08.

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas State Board of Healing Arts (hereafter "Board"). Applicant appears in person.

After hearing statements from the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

- Applicant was issued a temporary permit on October 10, 2000 to expire April 28, 2001.
- Applicant did not pass the NATA board certification examination on February 4, 2001.
- A request for second temporary registration was received from Registrant on April 6, 2001. This is Applicant's first request for a second temporary registration.
- 4. The date of the next NATA examination was April 21, 2001. Results are not yet available.
- 5. Pursuant to K.A.R. 100-69-9, no more than two temporary registrations shall be permitted to any one person.
- 6. The Board finds sufficient cause exists to grant Registrant a second temporary registration.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

- That a second temporary registration be granted to Applicant to expire on the date the results from the April, 2001 NATA examination are made available or on June 23, 2001, whichever should occur last.
- That this is a Final Order and is effective upon service of the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
