JOURNAL ENTRY OF SATISFACTION

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert (“Executive Director”), a duly authorized representative of the Board in accordance with K.S.A 2010 Supp. 77-514 to conduct summary proceedings pursuant to K.S.A 2010 Supp. 77-537, and, pursuant to the authority in K.S.A. 65-5401, *et seq.*, and, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, hereby enters the following findings of fact, conclusions of law, and Final Order in the above-captioned matter:

Findings of Fact

The Board has been shown the following facts:

1. Charles L Craig, P.A. (“Licensee”), **CONFIDENTIAL** Wichita, KS 67212, is licensed to practice as a physician assistant in the State of Kansas, License No. 15-00976, and has been so licensed since October 16, 2004.
2. On June 2, 2009, the Executive Director issued a Summary Order regarding Licensee’s license to practice as a physician assistant in the State of Kansas.
3. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing was requested, the Summary Order would become effective as a Final Order of the Board upon expiration of the time for requesting a hearing.

4. No hearing has been requested by any party.
5. The Summary Order ordered Licensee to submit proof of 23.5 hours of continuing education, due within 90 days of the effective date of the Summary Order.
6. The Summary Order provided that Licensee's license shall be suspended for failure to provide documented evidence of 23.5 continuing education hours within 90 days of the effective date of the Summary Order.
7. On December 12, 2011, Licensee submitted proof of the required hours of continuing education to the Board for satisfaction of the Summary Order.

Conclusions of Law


Based upon the Findings of Fact enumerated in Paragraphs #1 through #7 and the Applicable Law set forth above:

THE BOARD HEREBY CONCLUDES AS FOLLOWS:

8. On June 2, 2009, the Executive Director issued a Summary Order regarding Licensee's license to practice as a physician assistant in the State of Kansas.
9. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing was requested, the Summary Order would become effective as a Final Order of the Board upon expiration of the time for requesting a hearing.

10. No hearing has been requested by any party.
11. The Summary Order ordered Licensee to submit proof of 23.5 hours of continuing education, due within 90 days of the effective date of the Summary Order.
12. The Summary Order provided that Licensee's license shall be suspended for failure to provide documented evidence of 23.5 continuing education hours within 90 days of the effective date of the Summary Order.
13. On December 12, 2011, Licensee submitted proof of the required hours of continuing education to the Board for satisfaction of the Summary Order.

14. The Summary Order became effective as a Final Order on July 15, 2009.
15. Licensee has satisfied the provision of the Summary Order requiring submission of the specified continuing education hours.
16. Licensee has satisfied all requirements of the Summary Order and has no further obligation for compliance.
17. The Board shall maintain jurisdiction over this matter to issue any Order(s) deemed necessary and appropriate.


