JOURNAL ENTRY OF SATISFACTION OF CONSENT ORDER

COMES NOW the Kansas State Board of Healing Arts ("Board"), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 et seq., as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

- 1. On or about June 28, 2012, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-28a01, *et seq.* The Consent Order required Licensee attend and successfully complete a continuing education course for record-keeping, a continuing education course for pain management, and a continuing education course for prescribing; and to provide the Board documentation evidencing completion of the same by September 28, 2012. Further, Licensee was required to complete an essay on the requirements for proper communication between a physician assistant and a physician, and to submit this essay to the Board by September 28, 2012.
- 2. On or about September 23 2012, Licensee submitted the required essay related to proper communication between a physician assistant and a physician to the Board.

Journal Entry of Satisfaction of Consent Order Charles L. Craig, P.A. KSBHA Docket No. 12-HA00102 3. On or about November 12, 2012, Board designee, Kimberly Templeton, M.D.,

approved a modification to the continuing educational requirements contained in paragraphs

31(a) through (f) of the Consent Order based on the lack of live, in-person record-keeping

courses, pain management courses, and prescribing courses for physician assistants.

4. Dr. Templeton approved modifying the requirements to allow Licensee to,

instead, complete independent research on the topics of record-keeping, pain management, and

prescribing. Following the independent research, Licensee was required to write short essays,

with source references, on each of the topics, and submit the essays to the Board designee for

approval.

5. On or about November 12, 2012, Dr. Templeton determined Licensee's essay

submission regarding proper communication between a physician assistant and a physician

fulfilled the essay requirement of Licensee's Consent Order.

6. On or about January 29, 2013, Licensee submitted essays to the Board on the

topics of record-keeping, the pain management, and prescribing.

7. On or about February 15, 2013, Dr. Templeton determined Licensee's submitted

essays had fulfilled the modified educational requirements of Licensee's Consent Order.

8. Licensee has satisfactorily met all requirements of the Consent Order and shall

have no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from all

requirements of the Consent Order filed on June 28, 2012.
