**COMES NOW**, the Kansas State Board of Healing Arts ("Board") sitting in conference hearing this 27th day of June, 1997, to consider the May 6, 1997, request of Peter J. Cristiano, M.D. ("Licensee") for modification to the April 7, 1997 Stipulation and Agreement and Enforcement Order ("Stipulation") between the Board and Licensee. The Board is represented by Kevin K. LaChance, Disciplinary Counsel. Licensee appears in person without counsel.


The Board takes note of the request for modification, and the fact that the representative for the Board has no objections to the modification. The Board approves modification of the date for Licensee's attendance of the Mini-Residency on the Proper Prescribing of Controlled Dangerous Substances, to be held at the University of Medicine and Dentistry of New Jersey, Kennedy Memorial Hospital University Medical Centers to November 10-15, 1997, *vice* the May 1997 session.

Licensee further provided a request to the Board to review the original Stipulation for possible termination *ab initio*. In that said request was

received the day prior to this Board meeting, the Board rules the request not timely received for consideration at this time. The Board will pass this issue for consideration to the Board meeting currently scheduled to be held August 16, 1996, if Licensee makes a timely request for Board consideration of his request, subject to answer by counsel for the Board.


