PROPOSED DEFAULT ORDER

NOW, on this 11th day of December, 2004, comes on for conference hearing before the Kansas State Board of Healing Arts ("Board") the application for license as a physical therapist filed by Glen Cruz ("Applicant"). Charlene K. Abbott, Licensing Administrator, provides information to the Board. There are no other appearances.

After hearing the statements of Ms. Abbott and being duly advised in the premises, the Board finds, concludes and orders as follows:

1. Applicant is in default by his non-appearance.
2. This matter was originally scheduled for conference hearing on April 17, 2004.
3. On April 7, 2004, Applicant provided a letter at which time he requested that his application be "shelved indefinitely".
4. At the conference hearing held on April 17, 2004, the Board tabled consideration of Applicant's application until October 16, 2004, and an Amended Notice of Conference Hearing was filed and served setting the matter for 9:00 a.m. on that date.
5. On October 16, 2004, Applicant failed to appear and the matter was again set for conference hearing at 9:00 a.m. on December 11, 2004, and a Notice of Conference Hearing and Prehearing Order was filed and served on Applicant.
6. There are no disputed issues of fact and paragraphs 1 through 8 of the Summary Order

Denying Application filed February 26, 2004, are made the findings and orders of the Board and are incorporated herein by reference as though set out in full.


7. Applicant's Application remains incomplete since Applicant has not provided proof of completion of the academic requirements of a program in physician therapy.

IT IS THEREFORE ORDERED that Applicant's Application should be denied as incomplete for failure to provide satisfactory proof of successful completion of the academic requirements necessary for licensure, **PROVIDED, HOWEVER**, that nothing herein shall be construed as a disciplinary action nor shall this order prevent Applicant from reapplying for a license at a later date at such time as he believes he can provide evidence of completion of the academic requirements necessary for licensure.

PLEASE TAKE NOTICE that this is a proposed default order. A party may file a motion to vacate a proposed default order within seven days following service of the proposed order. Any such motion must be filed with the Executive Director at 235 S. Topeka Blvd., Topeka, KS 66603. A proposed default order becomes effective as a final agency order after the expiration of the time within which the party may file a written motion to vacate the proposed default order.


