Pursuant to the provisions of K.S.A. 1991 Supp. 65-

2833, Applicant meets the requirements to receive a license by

endorsement based upon the licenses issued to him by the states of

New York and Pennsylvania.

the requirements of K.S.A. 1991 Supp. 65-2833 to receive a license

to practice medicine and surgery in the state of Kansas by

endorsement based upon the New York and Pennsylvania licenses

previously issued to him.
