JOURNAL ENTRY OF SATISFACTION OF CONSENT ORDER


COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with K.S.A. 77-501, *et seq.*, and upon due consideration of the agency record, applicable statutes and regulation, and being duly advised in the premises, makes the following determinations:

1. On February 22, 2016, Kimberly Davies, M.D. (“Licensee”) entered into a Consent Order as a condition of licensure. The Consent Order was ratified by the Board and filed on April 13, 2016.
2. The Consent Order required Licensee to attend the continuing education courses titled “Medical Record Keeping Seminar” and “Prescribing Controlled Drugs” offered by the Center for Personalized Education for Physicians (“CPEP”).
3. On December 22, 2016, The Board received documentation evidencing Licensee’s successful completion on December 2, 2016, of the “Medical Record Keeping Seminar” offered by CPEP.
4. On July 18, 2016, The Board received documentation evidencing Licensee’s successful completion of the educational courses titled “Medical Record Keeping Seminar” and “Prescribing Controlled Drugs” offered by CPEP.
5. Licensee has met all requirements of the Consent Order.

IT IS THEREFORE ORDERED that Licensee has no further obligation for compliance with the Consent Order.
