JOURNAL ENTRY

NOW, on this 5th day of September, 1995, comes Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (hereinafter "Board") and states and finds as follows:

1. A Stipulation and Agreement and Enforcement Order was entered into between Chester R. Davis, M.D. (hereinafter "Licensee") and the Board which was filed in the Board office on July 7, 1994.

2. In paragraph 6(c) of the Stipulation and Agreement and Enforcement Order, Licensee was required to fulfill certain requirements for a period of one year.

3. The requirements imposed upon Licensee by paragraph 6(c) of the aforementioned Stipulation and Agreement and Enforcement Order constituted the only conditions or limitations which were imposed by such document on Licensee's license to practice medicine and surgery in the State of Kansas.

4. More than one year has expired since the filing of the Stipulation and Agreement and Enforcement Order, Licensee has satisfactorily complied with the provisions of paragraph 6(c) thereof and from and since July 7, 1995, there have been no restrictions or limitations on Licensee's license.

5. That although the Stipulation and Agreement and Enforcement Order does not provide for a date of termination, the expiration of one year since said document was filed has rendered the document without any continuing force or effect.

IT IS THEREFORE FOUND by the Executive Director that any and all restrictions and limitations placed on Licensee's license to practice medicine and surgery in the State of Kansas by the Stipulation and Agreement and Enforcement Order filed July 7, 1994 terminated on July 7, 1995 and that by Licensee's compliance with the terms of such document said Stipulation and Agreement and Enforcement Order should be terminated and be of no further force or effect.
