ORDER OF TERMINATION OF STIPULATION

NOW on this 27th day of April, 1996, comes for conference hearing before the Board of Healing Arts ("Board") the request of Harris Frazier Davis, P.A. ("Registrant") for termination of the Stipulation and Agreement and Enforcement Order ("Stipulation") of February 14, 1995 between Registrant and the Board. Kevin K. LaChance, Disciplinary Counsel, appears on behalf of the Board. There are no other appearances.

After hearing statements from counsel and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. A Stipulation was entered into between Registrant and the Board on February 14, 1995.
2. Paragraph 5(i) of said Stipulation provides that following monthly reports to Board staff listing all prescription orders transmitted, Registrant may petition the Board for termination of the Stipulation after the twelfth month of such reports.
3. Registrant completed the requirements of the Stipulation and by letter received by the Board on March 25, 1996, requested termination of the Stipulation.
4. Notice of Conference Hearing setting this matter for hearing at 11:30 a.m. on April 27, 1996 was filed herein on April 11, 1996 and served on Registrant on that same date.

5. Disciplinary Counsel for the Board does not oppose the termination of said Stipulation.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that any and all restrictions and limitations placed on Registrant's registration as a physician's assistant in the State of Kansas by the Stipulation and Agreement and Enforcement Order filed on February 14, 1995 should be terminated and be of no further force or effect.


