SUMMARY ORDER DENYING APPLICATION

NOW, on this 11th day of September, 2003, comes on before Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts ("Board"), the Application for Registration as a Physical Therapist filed by William Bianzon Dela Rosa, Jr. ("Applicant"). After reviewing the file and being duly advised in the premises, the Executive Director makes the following findings and orders for and on behalf of the Board:

1. Applicant filed an Application for Registration as a Physical Therapist with the Board on January 7, 2003.

2. Applicant has provided information to the Board indicating he graduated from the College of Physical Therapy of De La Salle University, Cavite, Philippines with a degree of Bachelor of Science in Physical Therapy on March 19, 1994.

3. The College of Physical Therapy of De La Salle University is not an educational program in physical therapy approved by the Board.

4. K.A.R. 100-29-3 provides that each person who received education from a school not approved by the Board shall submit with the application for registration an evaluation prepared for the state of Kansas by a Board approved credentialing agency.

5. On May 30, 2003, the Board received a Report of Evaluation of Educational Credentials dated May 20, 2003, prepared by the Foreign Credentialing Commission on Physical Therapy, Inc.

6. Foreign Credentialing Commission on Physical Therapy, Inc. has been approved by the Board as a credentialing agency.

7. K.A.R. 100-29-2 provides that if an applicant for registration received a degree from a program that was not approved by the Board at the time of an applicant's graduation, the Board may consider whether the program was equivalent to physical therapist schools that were approved by the American Physical Therapy Association at that time.


8. From the information provided as part of the Application, Applicant has not successfully completed the academic requirements of a program in physical therapy which is appropriate for registration of Applicant as a physical therapist in the state of Kansas..

IT IS THEREFORE ORDERED that the Application for Registration as a Physical Therapist filed by William Bianzon Dela Rosa, Jr. be denied.

PLEASE TAKE NOTICE that this is a summary order. A party to whom a summary order is issued may file a written request for a hearing withing 15 days following service of the summary order. If a hearing is not requested, the summary order shall become effective as a final order of the Board upon expiration of the time for requesting a hearing. 
