- 1. On or about April 15, 2013, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* The Consent Order required that Licensee attend and successfully complete "Neurology for the Non-Neurologist" course offered by Harvard Medical School's Department of Continuing Education and attend and successfully complete the Individualized Communication Course offered by the Center for Personalized Education for Physicians (CPEP).
- 2. On or about June 25, 2013, Licensee submitted documentation evidencing that he completed "The Critical Role of Physician Communication" course presented by CPEP on or about May 8, 2013.
- 3. On or about June 25, 2013, Licensee submitted documentation evidencing that he completed the "Neurology for Non-Neurologist" course presented by Harvard Medical School's
