**FINAL ORDER FOLLOWING CONFERENCE HEARING**

**NOW** on this 15<sup>th</sup> day of February 2003, comes on for conference hearing before the Kansas State Board of Healing Arts ("Board"), the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Alison E. Dobbie, M.D. ("Applicant").

Charlene K. Abbott, Licensing Administrator, presented information before the Board. There were no other appearances.

After reviewing the application and accompanying documents, hearing the information provided by Ms. Abbott and being otherwise duly advised in the premises, the Board finds and orders as follows:

1. On December 20, 2002, Applicant filed an Application for Licensure to receive a license to practice medicine and surgery in the state of Kansas.
2. As part of the Application, Applicant provided evidence that she had graduated from the University of Glasgow, Scotland, United Kingdom, on July 10, 1982.
3. The Board has not approved the University of Glasgow as an accredited medical school.
4. K.S.A. 65-2873(c)(2) provides that an applicant from a school that has not been accredited by the Board may be granted a license if the applicant has completed three years of postgraduate training as approved by the Board.

5. The Board has adopted K.A.R. 100-6-2(b) that requires applicants who graduated from a school of medicine that has not been accredited by the Board to present proof of completion of postgraduate training or residency training that is at least two years in length and that the program shall have been approved by the Council of Education of the American Medical Association or its equivalent.

6. Applicant's postgraduate training has not been approved by the Council of Education of the American Medical Association.

7. Applicant obtained four years of postgraduate training in Scotland from 1982 through 1986 and was a Clinical Assistant/Associate Professor from March 1997 through April 2002 at the University of Texas Health Science Center, San Antonio, Texas. Further, Applicant has been granted permanent licenses to practice medicine and surgery in the United Kingdom and in Texas.

8. The training and experience obtained by Applicant in both Scotland and the University of Texas Health Science Center in San Antonio, Texas, is at least equivalent to two years of postgraduate training in a program approved by the Council of Education of the American Medical Association.


9. Applicant meets the requirements for licensure under K.S.A. 65-2873 and K.A.R. 100-6-2(b) and is eligible for a permanent license to practice medicine and surgery in the state of Kansas.

**IT IS THEREFORE ORDERED** that the above findings are made the order of the Board and that Applicant is eligible for a license to practice medicine and surgery under the provisions of K.S.A. 65-2873.

**IT IS FURTHER ORDERED** a temporary permit may be granted to Applicant upon payment of the appropriate fee and that Applicant's Application for Licensure will be considered at the meeting of the Board to be held April 26, 2003, to grant a permanent license to Applicant.


