**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW, on this 5th day of April, 1997, this matter comes on for conference proceedings before the Kansas Board of Healing Arts (hereinafter "Board") at the request of Pravina Balwant Dongre (hereinafter "Registrant") to grant a second temporary registration pursuant to K.S.A. 65-5408(d).

Charlene K. Abbott, Licensing Administrator, presents information before the Board. Registrant did not appear.

After reviewing the file, hearing statements of the party and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

---

**FINAL ORDER FOLLOWING CONFERENCE HEARING**

1. A request for a second temporary registration was received from Registrant on March 13, 1997.

2. Notice of Conference Hearing setting this matter for hearing at 10:45 a.m. on April 5, 1997 was filed herein on March 20, 1997 and served on Registrant on that same date.

3. Registrant has applied for permanent registration as an occupational therapist, but has not passed an exam approved by the Board as required by K.S.A. 65-5406(a)(3).

4. Registrant was granted temporary registration number 9623074 which will expire April 22, 1997.

5. Pursuant to K.S.A. 65-5408(d), not more than one temporary registration shall be permitted to any one person without the majority approval of the members of the Board.

6. The Board finds that sufficient cause exists to grant Registrant to second temporary registration.

7. Upon payment of the appropriate fees, Registrant should be granted a second temporary registration to expire June 30, 1997.


**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED** as follows:

A. That upon payment of the appropriate fee, a second temporary registration be granted to Registrant to expire June 30, 1997.

B. That this is a Final Order and is effective upon service on the parties. Any party may, within fifteen (15) days after service file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.


