NOW, on this 14th day of August, 2009, the above-entitled matter comes on before the Kansas State Board of Healing Arts (Board) on Applicant's application for licensure to practice chiropractic in Kansas. Applicant appears in person, *pro se*. Stacy R. Bond, Associate Litigation Counsel, appears for the Board. There are no other appearances.

WHEREUPON, the Board having the agency record before it, being duly advised in the premises and hearing the statements and arguments of the parties, FINDS and ORDERS as follows:

1. On or about March 2, 2009, Applicant submitted an application to practice chiropractic in Kansas. The application was deemed complete and filed on June 23, 2009.

2. Applicant disclosed an absence from active practice since January of 2005.

3. Applicant further disclosed that he changed his licensure status from active to exempt on January 1, 2007.

4. On March 6, 2009, applicant disclosed to Board staff that he gave up active practice due to (confidential)

5. On March 19, 2009, applicant stated that (confidential) did not interfere with his ability to practice.

6. The Board grants Applicant an active license contingent upon applicant taking and passing the Special Purpose Examination for Chiropractic (SPEC) before August 2010.
