JOURNAL ENTRY AND FINAL ORDER OF  
SATISFACTION OF CONSENT ORDER

NOW, on this 12<sup>th</sup> day of August 2011, comes before the Kansas State Board of Healing Arts ("Board") the request of Rory A. Dopps, D.C. ("Licensee") for termination of terms of probation imposed under the terms of a Consent Order in Docket No. 10-HA00117. Licensee appears *pro se*. Reese H. Hays, Litigation Counsel, appears on behalf of the Petitioner Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the file, hearing the testimony and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings of fact, conclusions of law and order:

I. Findings of Fact

1. Rory A. Dopps, D.C. ("Licensee") is licensed to engage in the practice of chiropractic in the State of Kansas, License No. 01-04902, and has been so licensed since approximately August 14, 2004.

2. Licensee's last known mailing address provided to the Board is: confidential  
confidential Wichita, Kansas 67202.

3. On or about April 20, 2010, Licensee entered into a Consent Order with the Board wherein Licensee agreed to terms of probation for a period of at least one year. The terms of probation included: Licensee was required to complete specified remedial education at his own expense, on or before July 30, 2010; and, Licensee's practice was subject to monitoring by Coding and Compliance Initiatives, Inc. ("CCI"). Additionally, Licensee's practice monitor was required to provide the Board with quarterly monitoring reports during the probationary period.

4. The terms of the Consent Order allow Licensee to petition the Board for termination of the probation upon satisfactory completion of all probationary terms in the Consent Order.

5. On or about July 14, 2011, the Board received from Licensee a request for termination of the probation imposed by the Consent Order.

6. On July 18, 2011, the Petitioner Board filed a Response to Licensee's Motion. The Response document included the following exhibits as attachments:

- a. Exhibit A: documentary evidence of Licensee's completion of the continuing education required by the Consent Order;
- b. Exhibit B: Licensee's first quarterly report, dated July 14, 2010;
- c. Exhibit C: Licensee's second quarterly report, dated July 14, 2010;
- d. Exhibit D: Licensee's third quarterly report, dated March 14, 2011; and,
- e. Exhibit E: Licensee's fourth quarterly report, dated June 27, 2011.

## **II. Applicable Law**

- a. K.S.A. 77-501, *et seq.* – Kansas Administrative Procedure Act
- b. K.S.A. 65-2801, *et seq.* – Kansas Healing Arts Act

### III. Policy Statement

The public policy of regulating the practice of healing arts in the State of Kansas is set forth in K.S.A. 65-2801:

Recognizing that the practice of the healing arts is a privilege granted by legislative authority and is not a natural right of individuals, it is deemed necessary as a matter of policy in the interests of public health, safety and welfare, to provide laws and provisions covering the granting of that privilege and its subsequent use, control and regulation to the end that the public shall be properly protected against unprofessional, improper, unauthorized and unqualified practice of the healing arts and from unprofessional conduct by persons licensed to practice under this act.

### IV. Conclusions of Law


Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

### V. Order

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS,** that Licensee has satisfied all terms and conditions of the Consent Order and that Licensee's request to terminate the terms of probation imposed by the Consent Order is hereby granted.

**IT IS FURTHER ORDERED** that the Board shall maintain jurisdiction over this matter to issue any future order(s) deemed necessary and appropriate.
