JOURNAL ENTRY OF SATISFACTION AND GRANTING ACTIVE LICENSE

The Kansas State Board of Healing Arts ("Board"), by its Executive Director, Tucker L. Poling, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record, the applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about March 19, 2020 Jeffrey Dunn, D.O. ("Licensee") submitted an Application for change of Designation/Type requesting his license status be changed from Exempt to Active.
2. On August 14, 2020, this matter came before the Board for a Conference Hearing on Licensee's Application for Change in Designation/Type, which was opposed by the Disciplinary Panel until such time Licensee demonstrated his clinical competence by completing the Center for Personalized Education for Professionals ("CPEP") Reentry to Clinical Practice Program.
3. On September 14, 2020, a Final Order in this matter was issued by the Board, ordering Licensee to complete the CPEP Reentry to Clinical Practice Program.
4. On November 4-5, 2020, Licensee completed the CPEP Re-entry to Clinical Practice

Program Clinical Skills Evaluation.


5. The CPEP evaluation report concluded Licensee could return to clinical practice of inpatient internal medicine without a structured Re-entry Plan.
6. Licensee has satisfactorily met all requirements of the Final Order and has no further obligations for compliance with the Final Order.

IT IS THEREFORE ORDERED that Licensee's Application for Change of Designation/Type from Exempt to Active be **GRANTED**.


