**FINAL ORDER AND JOURNAL ENTRY OF SATISFACTION  
OF REQUIREMENTS OF FINAL ORDER**

NOW ON THIS 13<sup>th</sup> day of September, 2010, the above-entitled matter comes on before Kathleen Selzler Lippert, Executive Director of the Kansas State Board of Healing Arts (“Board”). After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations.

1. On August 23, 2010, the Executive Director issued a Summary Order regarding the license of Jerome C Duran, R.T. (“Licensee”) to practice as a respiratory therapist in the state of Kansas. The Summary Order contained a provision assessing a \$100 civil fine against Licensee for failure to have met the continuing education requirement at the time of renewal, due and payable within thirty (30) days of the effective date of the Summary Order.

2. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would be come effective as a final order of the Board upon expiration of the time for requesting a hearing.

3. No hearing has been requested by any party; therefore the Summary Order became effective as a Final Order on September 13, 2010.

4. On August 23, 2010, Licensee remitted \$100.00 to the Board for satisfaction of the \$100 civil fine.

5. Licensee has satisfied all requirements of the Final Order and has no further obligation for compliance.


**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from the requirements of the Final Order.
