**FINAL ORDER GRANTING WAIVER OF TRANSCRIPT REQUIREMENT  
AND GRANTING LICENSURE**

NOW on this 17<sup>th</sup> day of June 2011, comes before the Kansas State Board of Healing Arts ("Board") the application of Leonard Dwenger, RT ("Applicant") for a license to practice respiratory therapy in the State of Kansas and for a waiver of the application requirement to provide an official transcript from his respiratory therapy educational program. Licensee appears *pro se*. Jessica Bryson, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-5501 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the file, hearing the statements and arguments of Ms. Bryson, hearing the testimony of the Applicant and being otherwise duly advised in the premises, the Board makes the following findings of fact, conclusions and order:

1. On or about April 20, 2011, Applicant submitted to the Board an application for a license to practice radiologic technology in the State of Kansas, and requested waiver of the application requirement specified in K.A.R. 100-55-1 to provide an official transcript from his respiratory therapy educational program. Such application was deemed complete and filed with the Board on May 19, 2011.

2. Applicant's last known mailing address provided to the Board is: confidential

3. Applicant graduated in 1984 from the University of Chicago Hospital and Clinics Advanced Respiratory Care Program in Chicago, Illinois.

4. Applicant has been unable to provide an official transcript from his respiratory therapy educational program because the program is no longer in operation.


5. Applicant is certified and registered by the National Board for Respiratory Care by virtue of examination.

6. Applicant holds active and unrestricted licenses in Utah, Ohio, South Dakota and Iowa.

7. Applicant has satisfactorily demonstrated that he is eligible for a waiver and grant of licensure pursuant to K.S.A. 65-5508(a) based on proof of his current licensure as a respiratory therapist in Utah, Ohio, South Dakota and Iowa.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS** that Applicant is hereby granted a waiver of the application requirement to provide an official transcript from his respiratory therapy educational program and is granted a license to practice respiratory therapy in Kansas effective June 17, 2011.


