FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 11th day of February, 1995, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the request submitted by Rajab Tongwa Echessa (hereafter "Applicant") for a second temporary registration. Charlene K. Abbott, Licensing Administrator, presented information to the Board regarding Applicant's request. There were no other appearances.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. Applicant received a temporary registration on April 18, 1994 and which will expire on April 18, 1995.
2. On January 18, 1995, a request was received from Applicant for a second temporary registration.
3. At its meeting on February 11, 1995, the Board considered Applicant's request.

IT IS THEREFORE ORDERED as follows:

FINAL ORDER FOLLOWING CONFERENCE HEARING

A. That the findings here and above made be and the same are made the Order of the Board.

B. Pursuant to K.S.A. 65-5408(d) Applicant is granted a second temporary registration in order that Applicant may sit for and take the next American Occupational Therapy Certification Board (AOTCB) examination to be given July 22, 1995. Such second temporary registration will be granted for a period of time as results from the July 22, 1995 examination become available to the Board or until October 14, 1995, whichever shall come first.

C. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service file a Petition for Reconsideration. A Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
