OF REQUIREMENTS OF FINAL ORDER**


NOW on this 26th day of March, 2013, this matter comes before Kathleen Selzler Lippert Executive Director, Kansas Board of Healing Arts ("Board"), concerning Licensee's satisfaction of all requirements contained in the Final Order which was filed on May 12, 2008. Wherefore, the Board finds as follows:

1. In the Board's June 27, 2008, Final Order on Reconsideration, Licensee was fined in the amount of \$10,000. Licensee paid \$3500 on April 4, 2008, prior to the Final Order on Reconsideration.
2. The fine was stayed pending judicial review. Upon the conclusion of judicial review, the fine was restored, and Licensee was ordered to pay the remainder of the fine in full by September 1, 2012.
3. On August 29, 2012, a Journal Entry Allowing Monthly Payments Towards Fine was filed. The Journal Entry allowed Licensee to make monthly payments of \$1,100 for five months and a sixth and final payment of \$1000.
4. Licensee has satisfied all requirements of the Final Order on Reconsideration and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from the requirements of the Final Order on Reconsideration filed on June 27, 2008.

IT IS SO ORDERED.


