JOURNAL ENTRY AND ORDER TERMINATING THE JOINT STIPULATION AND ENFORCEMENT AGREEMENT ENTERED INTO ON OCTOBER 16, 2000

NOW on this ____ day of October, 2002, the Board is prepared to sign this Order and Journal Entry terminating the Joint Stipulation and Enforcement Agreement entered into on October 16, 2000 between Dr. David Edalati and the Kansas Board of Healing Arts. The Board hereby makes the following findings of fact:

- 1) On October 16, 2000, David D. Edalati (Licensee) and the Kansas Board of Healing Arts (Board) entered into a Stipulation and Enforcement Agreement resolving a pending disciplinary proceeding which had been commenced on April 21, 2000.
- 2) The agreement between Licensee and the Board established a physician monitoring program which was to last from October 16, 2000 until October 16, 2002.
- 3) Licensee has now complied with all the terms of the Stipulation and Agreement and Enforcement Order. Furthermore, the Licensee's monitoring physician, Dr. Halla Moussa, has stated that the Licensee complied with all aspects of the monitoring program.
- 4) At midnight on October 16, 2002 all licensing restrictions placed on Licensee were completely removed. There remains no outstanding or pending issues involving this Licensee and the Board.

WHEREFORE, as of October 16, 2002, and as a result of Licensee's total compliance

with each of the provisions of the Joint Stipulation and Enforcement Order entered into between Licensee and Board, the Board hereby terminates the Joint Stipulation and Enforcement Order dated October 16, 2000.
