FINAL ORDER

NOW on this 15th day of February, 1997, this matter comes on for conference proceedings before the full Board at the request of Lawrence L. Emmons, M.D. (hereinafter "Applicant") to grant a license to practice medicine and surgery, pursuant to K.S.A. 65-2801 *et. seq.* There are no appearances.

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts (hereinafter "Board"). There are no other appearances.

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board makes the following findings of fact , conclusions of law and orders:

1. An application for endorsement was received from Applicant on November 25, 1996.
2. Notice of Conference Hearing setting this matter for hearing at 11:15 a.m., Saturday, February 15, 1997, was filed herein on January 31, 1997 and served on Applicant on that same date.
3. Applicant has applied for permanent licensure to practice medicine and surgery, attended the University of Miami School of Medicine receiving a two-year medical degree, and holds or has held licenses in Colorado, Montana, and New Mexico.

4. Applicant was granted temporary permit number 9722351, which expires August 15, 1997.


5. Applicant has met the education requirements of the healing arts act.

IT IS THEREFORE ORDERED that Applicant be placed upon the list for approval of licensure to practice medicine and surgery, such list to be presented and acted upon by the Board at the April 5th Board meeting.

This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.


