JOURNAL ENTRY GRANTING REQUEST FOR RECONSIDERATION

COMES NOW the Kansas State Board of Healing Arts ("Board") by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, and considers the Petition for Reconsideration of the Final Order Revoking License, filed by Derek Ensz, LRT (Licensee) in the above-captioned matter, pursuant to the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., and in accordance with the Kansas Healing Arts Act, K.S.A. 65-2801, et seq.

Upon a review of the Petition for Reconsideration and the administrative record, the Board finds as follows:

- Licensee's last known mailing address provided to the Board is: 3312 Homestead,
 Hutchinson, Kansas 67502.
- 2. On or about August 29, 2011, the Board filed a Final Order in the above-captioned matter (Final Order) revoking Licensee's license to practice radiologic technology in the State of Kansas due to Licensee's failure to comply with the terms of a Consent Order entered on or about April 19, 2011.
- 3. On or about September 26, 2011, Licensee, by and through legal counsel, filed a petition for judicial review of the Final Order in Shawnee County District Court.
- 4. On or about October 17, 2011, Licensee, by and through legal counsel, filed an untimely Petition for Reconsideration of the Final Order with the Board. Licensee's petition does

not request a stay of the license revocation. Licensee's Petition for Reconsideration sets forth

unique circumstances and brings new facts and evidence to the Board's attention which may

have changed the Board's action in the underlying matter had those facts and evidence been

made known to the Board at the time the Final Order was filed.

6. On or about October 25, 2011, Licensee, by and through legal counsel, filed a

motion to dismiss the petition for judicial review of the Final Order.

7. On or about October 31, 2011, Licensee's petition for judicial review was dismissed

without prejudice by the Shawnee County District Court.

8. The Board has authority to issue Initial and Final Orders, and maintains

jurisdiction over matters before it to issue additional orders deemed necessary and appropriate.

IT IS THEREFORE ORDERED that, in the interest of justice, the Board hereby orders

reconsideration of the Final Order in this matter.

IT IS FURTHER ORDERED that on Friday, December 2, 2011, the Board will hold

further proceedings on this matter. A formal notice of hearing specifying the time and place of

the hearing will be sent to Licensee at Licensee's address of record with the Board and to

Licensee's counsel.

IT IS FURTHER ORDERED that the Board shall maintain jurisdiction over this matter

to issue any additional order(s) deemed necessary and appropriate.
