B. The provisions of paragraph 51 may not substitute or replace all or part of the requirements in paragraph 50. The Board strongly recommends that Ms. Enzbrenner complete the provisions of paragraph 51.

THEREFORE, the Board APPROVES the Consent Order as AMENDED above.
