JOURNAL ENTRY APPROVING CONSENT ORDER AS AMENDED

On February 12, 2021, the Kansas State Board of Healing Arts (“Board”) held an electronic virtual hearing to review the proposed Consent Order between the Board and Janet M. Enzbrenner, L.R.T. (“Ms. Enzbrenner”). Todd Hiatt, Litigation Counsel, and Tammie L. Mundil, Deputy Litigation Counsel, appeared by video, to present the position of the disciplinary panel of the Board. The Board, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and being otherwise duly advised in the premises, **APPROVES** the Consent Order as **AMENDED** by the Board with the following changes outlined in the Journal Entry. The Board shall maintain jurisdiction over this matter to issue any order(s) deemed necessary and appropriate in the circumstances.

1. On February 12, 2021, the Board reviewed the proposed Consent Order. The Board made two amendments to the proposed Consent Order and the Board approved the proposed Consent Order with the two amendments. The two amendments are:
 - A. The provisions of paragraph 50 are required to be completed by Ms. Enzbrenner and
