ORDER OF RETROACTIVE REINSTATEMENT OF LICENSE

NOW on this 14th day of October, 1995, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole in a summary proceeding pursuant to the provisions of K.S.A. 77-537, the request of Michael Estivo, D.O. (hereinafter "Licensee") for retroactive reinstatement of active license. Licensee did not appear.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. Licensee's license was cancelled for non-renewal on August 14, 1995. Said license was originally issued on June 15, 1990.
2. On August 16, 1995, Licensee submitted his application for license renewal and said license was reinstated effective August 17, 1995.
3. By letter received October 3, 1995, Licensee requested that the Board retroactively reinstate his license to practice medicine and surgery to August 14, 1995.
4. The failure of Licensee to renew his license and the cancellation of such license was due to inadvertence and mistake in the delay in CME certification required by K.S.A. 65-2809(b).

ORDER OF RETROACTIVE REINSTATEMENT OF LICENSE

IT IS THEREFORE BY THE BOARD ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of the Board.

B. That license number 05-23235 issued to Michael P. Estivo, D.O., cancelled on August 14, 1995 and reinstated on August 17, 1995, be retroactively reinstated to August 14, 1995 to reflect that Licensee has continuously held a current license from and since August 14, 1995.

C. That as a condition of the aforementioned retroactive reinstatement of license, an administrative fine in the amount of fifty dollars (\$50) be assessed to Licensee for inadvertence and mistake in allowing his license to be cancelled for non-renewal on August 14, 1995. Payment of said fine is to be received in the board office within thirty (30) days of service of this Order.

D. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.


