JOURNAL ENTRY TO MODIFY FINAL ORDER

The Kansas State Board of Healing Arts ("Board"), by its Interim Executive Director, Tucker L. Poling, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record, the applicable statutes and regulations, the filings in this matter, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about March 24, 2020, a Final Order was issued by the Board against the Kansas medical license of Hamad I. Farhat, M.D. ("Licensee"). The Final Order found a violation of K.S.A. 40-3404 failure to: (1) pay the premium surcharges; and (2) have coverage from the Kansas Health Care Stabilization Fund ("KHCSF") in place while holding an active license to practice medicine and surgery in Kansas.
2. The Final Order issued a \$500.00 civil fine and suspended the Licensee's license until such time as Licensee came into compliance with the KHCSF.
3. On or about April 14, 2020, Litigation Counsel for the Board filed a Motion to Modify the Final Order and/or Lift Suspension. The motion stated Licensee had

become compliant with the KHCSF and requested termination of Licensee's suspension.

4. Licensee has satisfactorily complied with the KHCSF requirement of the Final Order; the Motion is granted, and the suspension of Licensee's license to practice medicine and surgery in Kansas is **LIFTED** and the license is **RESTORED** to active status.

IT IS SO ORDERED.


