**JOURNAL ENTRY OF DISMISSAL**

NOW, on this 24th day of February, 1995, the above-entitled matter comes before Floyd E. Gehrt, the presiding officer appointed in the formal proceedings now pending. After reviewing the file and being otherwise duly advised in the premises, the presiding officer finds and orders as follows:

1. That a Stipulation and Agreement and Enforcement Order was filed in the above-entitled matter on February 13, 1995.

2. That in paragraph 6 of the aforementioned Stipulation, it was provided that the purpose and intent of the Stipulation was to provide for settlement of all issues without the necessity of proceeding to a formal disciplinary hearing.

3. That in paragraph 9(b) of the aforementioned Stipulation, Gary L. Farmer, M.D., (hereafter "applicant") agreed to withdraw his application for licensure by endorsement to practice medicine and surgery in the State of Kansas.

4. That it was the application for license by endorsement which formed a basis for the Board of Healing Art's order converting to formal proceedings and authorizing appointment

of the presiding officer and resulted in the commencement of formal proceedings in this matter.

5. That by the withdrawal of applicant's application pursuant to the Stipulation and Enforcement Order filed herein, this matter should be dismissed as moot.

**IT IS THEREFORE ORDERED** that the formal proceedings now pending in the above-entitled matter be dismissed with prejudice.

**IT IS SO ORDERED.**
