**ORDER GRANTING RETROACTIVE EXTENSION OF
 REINSTATEMENT OF POSTGRADUATE PERMIT**

NOW ON THIS 23RD of August, 2003, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a Conference Proceeding pursuant to the provisions of K.S.A. 77-533, the request of Tanya Filardi, M.D. (hereafter "Petitioner") for retroactive extension of reinstatement of postgraduate permit. Charlene Abbott, Licensing Administrator, presents information to the Board. Petitioner appears in person.

After hearing statements of the parties and being duly advised in the premises, the Board finds as follows:

1. Petitioner was issued her first postgraduate permit number 94-05235, effective January 1, 2000 through December 31, 2002. At the time permit was issued, Kansas law provided for three-year permits.
2. On May 1, 2003 the Board received Petitioner's application for a second temporary permit. Approval for the second permit was granted on May 1, 2003 by Lawrence T. Buening, Executive Director.
3. Petitioner was without any license or permit from January 1, 2003 through April

30, 2003.

4. Petitioner did not appear for the June 7, 2003 hearing on her request for retroactive reinstatement due to misinformation about the meeting date.
5. Petitioner was unaware of the expiration of permit or the notice of cancellation.
6. The Board finds sufficient cause exists to grant Petitioner retroactive extension of reinstatement of postgraduate permit from January 1, 2003 to April 30, 2003.

IT IS THEREFORE ORDERED AS FOLLOWS:

1. That the findings here and above made be and the same are made the order of the Board.
2. That the postgraduate permit number 94-05235 of Tanya Filardi, M.D. to practice medicine and surgery in the State of Kansas originally issued January 1, 2000, be made effective retroactively from and after January 1, 2003.

IT IS SO ORDERED.


