JOURNAL ENTRY GRANTING DISMISSAL

This matter comes before Presiding Officer Durrett¹, on a Notice of Dismissal (“Notice”) filed on March 24, 2021, by Steven M. Lehwald, Associate Litigation Counsel, on behalf of the Disciplinary Panel #35 (“Petitioner”). This Journal Entry is entered pursuant to K.S.A. 77-551(c). The Presiding Officer dismisses the Petition as more fully described below.

1. On or about June 23, 2020, a Petition was filed in this matter alleging Kenneth A. Fischer, M.D., (“Licensee”) had violated provisions of the Kansas Healing Arts Act, K.S.A. 65-2801 *et seq.*
2. On or about March 24, 2021, a Notice of Dismissal was filed notifying the Court that the parties have reached an accord settling all underlying controversies and asking the Court to dismiss the docket with prejudice.
3. Since there is no longer an issue to be decided by the Presiding Officer in this matter, dismissal is warranted in the circumstances.

THEREFORE, the Petitioner’s Petition is **DISMISSED** with prejudice.
