ORDER OF RETROACTIVE MODIFICATION
TO REGISTRATION STATUS

NOW, on this 17th day of April, 1993, comes on for consideration before the Kansas State Board of Healing Arts, sitting as a whole as Presiding Officer in a Conference Proceeding pursuant to the provisions of K.S.A. 77-533, the request of Barbara A. Roecker Fisher, R.T., (hereafter "Registrant") for retroactive modification of registration status. Registrant appeared in person pro se.

After reviewing the request and being otherwise duly advised in the premises, the following findings are made:

1. Registrant was issued a registration as a respiratory therapist on August 15, 1987 pursuant to K.S.A. 65-5506.
2. Said registration was cancelled for non-renewal on February 25, 1992.
3. Registrant continued to practice as a respiratory therapist until her reinstatement of registration on February 18, 1993.
4. It was due solely to inadvertence and mistake that Registrant failed to renew her license and the same was cancelled on February 25, 1992.

IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

A. That the findings here and above made be and the same are made the order of the Board.

B. The status of the registration issued under K.S.A. 65-5512 to Barbara A. Roecker Fisher, R.T. to practice as a respiratory therapist in the state of Kansas should be retroactively modified to reflect that Registrant has continuously held an active registration from and since August 15, 1987.

C. That as a condition of aforementioned retroactive modification to the registration, an administrative fine in the amount of two-hundred (\$200.00) dollars be assessed to Registrant for her inadvertence and mistake in practicing as a respiratory therapist without the benefit of current registration as such from February 25, 1992 to February 18, 1993. Payment of said fine to be received in the Board office within ninety (90) days of service of this Order.

D. This is a Final Order and is effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
