JOURNAL ENTRY OF CONSENT ORDER MODIFICATION


NOW on this 8th day of August, 2014, comes on for consideration before the Kansas State Board of Healing Arts (“Board”), the proposed Consent Order of the parties. In accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and the applicable statutes and otherwise being duly advised in the premises, the Board makes the following determinations:

1. The parties have entered into a Consent Order to resolve allegations that Sanford Fitzig, M.D. (“Licensee”) has violated the Healing Arts Act.
2. The Consent Order contains a provision for Licensee to complete the Center for Personalized Education for Physician’s in-person Medical Record Keeping Seminar.
3. At the time of presentation of the Consent Order to the Board, Licensee changed his license designation from “active” to “inactive.” Licensee stated that he has “formally retired” from the practice of medicine.
4. The parties requested that the Board modify the terms of the Consent Order such that Licensee shall not be required to complete the Medical Record Keeping Seminar since he is no longer practicing medicine.
5. The Board approved the Consent Order as written with the modification that Licensee shall not be required to complete the Medical Record Keeping Seminar.

6. In the event that Licensee requests an active license in the future, the Board shall maintain jurisdiction over this matter to determine if Licensee should be required to complete the Medical Record Keeping Seminar.

7. All other provisions of the Consent Order shall remain in full force and effect.
