JOURNAL ENTRY OF SATISFACTION OF CONSENT ORDER

COMES NOW the Kansas State Board of Healing Arts ("Board"), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about April 15, 2013, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Physician Assistant Licensure Act, K.S.A. 65-28a01, *et seq.* On or about April 26, 2013, the Board accepted and ratified this Consent Order. The Consent Order required that Licensee attend and successfully complete ten (10) additional continuing education credits specifically in the area of Proper Prescribing Practices, and to provide the Board documentation evidencing completion of the same by October 31, 2013. Further, the Consent Order required Licensee to provide a copy of his current supervising physician protocol to the Board by April 19, 2013.

2. Pursuant to the Consent Order, Licensee was suspended thirty (30) days beginning April 17, 2013.

3. On or about March 21, 2013, Licensee submitted documentation evidencing his

current supervising physician protocol to the Board.


4. On or about May 14, 2013, Licensee submitted documentation evidencing completion of "Appropriate Prescribing of Controlled Substances for Physician Assistants" course presented by the Medical University of South Carolina Physician Assistant Program.

5. Licensee's suspension terminated on or about May 18, 2013.

6. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

IT IS THEREFORE ORDERED that Licensee is hereby discharged from all requirements of the Consent Order filed on April 15, 2013.
