ORDER OF RETROACTIVE REINSTATEMENT OF REGISTRATION

NOW on this 27th day of April, 1996, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole in a conference hearing, the request of Robert L. Fletcher, P.A. (hereafter "Registrant") for retroactive reinstatement of his registration as a physician's assistant.

Charlene K. Abbott, Licensing Administrator, presents information to the Board. There are no other appearances. After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. Registrant was granted registration number 15-00387 on April 17, 1993. Said registration was cancelled on February 17, 1996 for failure to renew, and then reinstated on February 22, 1996.
2. On February 28, 1996, the Board received Registrant's request for retroactive reinstatement of his registration to February 17, 1996.
3. The failure to Registrant to timely submit his Application for Renewal was due to clerical error on the part of Registrant.

ORDER OF RETROACTIVE REINSTATEMENT OF REGISTRATION

IT IS THEREFORE BY THE BOARD ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of the Board.

B. That registration number 15-00387 issued to registrant Robert L. Fletcher, P.A., last reinstated on February 22, 1996, be retroactively reinstated to February 17, 1996, to reflect that he has continuously held a registration as a physician's assistant from and since April 17, 1993.

C. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
