**ORDER OF RETROACTIVE REINSTATEMENT OF LICENSE**

NOW, on this 14<sup>th</sup> day of December, 2002, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as presiding officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, the request of Tony J. Fornelli, II, D.P.M. (hereafter "Licensee") for retroactive reinstatement of license. Licensee appeared *pro se*. Charlene K. Abbott, Licensing Administrator, presented information to the Board.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. Licensee was issued a license to practice podiatry in Kansas on April 27, 1996.
2. Licensee's license number, 12-00279, was canceled November 1, 2002 for failure to renew.
3. Licensee's Application for Reinstatement was received on November 19, 2002 and Licensee's license was reinstated on that date.
4. A letter requesting retroactive reinstatement was received on November 21, 2002.
5. The failure of Licensee to renew his license and the cancellation of such license on November 1, 2002 was due solely to inadvertence, negligence and mistake and not due to any intentional conduct on the part of Licensee.

6. Proof of insurance has been provided.

7. For good cause shown, Licensee's license, originally reinstated on November 19, 2002, be made effective retroactively from and after November 1, 2002.

**IT IS THEREFORE ORDERED AS FOLLOWS:**

1. That the findings here and above made be and the same are made the order of the Board.

2. That the license of Tony J. Fornelli, II., D.P.M. to practice podiatry in the state of Kansas originally canceled on November 1, 2002 and reinstated on November 19, 2002 be reinstated as of and be made retroactive from and after November 1, 2002.

**IT IS SO ORDERED.**


