**ORDER AMENDING STIPULATION
AND MODIFYING ENFORCEMENT ORDER**

NOW, on this 13th day of April, 1991, comes on before the Kansas State Board of Healing Arts (hereafter "Board") for summary proceedings, the request of Anthony Francis, M.D. (hereafter "Licensee") for Amendment to Stipulation and Modification of Enforcement Order.

Licensee appears by and through his attorney, Robert S. Jones, of Salina, Kansas. Steve A. Schwarm appears as Litigation Counsel for the Board. There are no other appearances.

After reviewing the file, hearing statements of counsel and being otherwise duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. Notice of the these summary proceedings was served on Licensee and his counsel on April 1, 1991 and has been duly filed herein and is hereby approved.

2. Licensee is currently licensed in the State of Kansas to practice medicine and surgery and holds License No. 17828.

EXHIBIT C

3. On May 8, 1989, Licensee and Board entered into a Stipulation, a copy of which is attached hereto and marked as "Exhibit A".

4. On May 8, 1989, the Board entered an Enforcement Order based upon the aforementioned Stipulation, a copy of which is attached hereto and marked as "Exhibit B".

5. That paragraph 3 of the Stipulation dated May 8, 1989 between the Board and Licensee and paragraph 3 of the Enforcement Order dated May 8, 1989 entered based upon the aforementioned Stipulation should be amended in their entirety to read as follows:

"3. That, Licensee will limit his practice to that of orthopedic surgery and minor emergency procedures, and will treat only such outpatients and patients within a hospital and/or minor emergency facilities affiliated with a hospital as normally come under his care."

6. That except as hereby amended and modified, the terms and conditions of the Stipulation attached hereto as Exhibit A and the Enforcement Order attached hereto as Exhibit B shall remain in full force and effect.

IT IS THEREFORE BY THE BOARD ORDERED that paragraph 3 of the Stipulation, a copy of which is attached hereto as "Exhibit A", and paragraph 3 of the Enforcement Order, a copy of which is attached hereto as "Exhibit B", should be and are hereby amended as above-stated.


IT IS FURTHER ORDERED that either party may be entitled to an administrative review of this Order if written request is received




