FINAL ORDER GRANTING LICENSURE BY ENDORSEMENT

NOW on this 14th day of February 2014, comes before the Kansas State Board of Healing Arts (“Board”) the application of Zoe Freedman, D.C. (“Applicant”) for a license to practice chiropractic in the State of Kansas. Applicant appears *pro se* via Skype. Reese Hays, Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order following a formal hearing in the above-captioned matter. After reviewing the agency record and exhibits offered by Applicant, hearing the testimony of Applicant and Applicant’s witness, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. On or about January 15, 2014, Applicant submitted an application to the Board for a license to practice chiropractic in the State of Kansas.
2. Applicant requests that she be granted licensure by endorsement pursuant to K.S.A. 65-2833, based on her chiropractic license in the United Kingdom of Great Britain which was granted in 2005.

3. Dr. Freedman graduated with a Masters in Chiropractic from the Anglo-European College of Chiropractic in Bournemouth, UK in 2005. In 2009, Dr. Freedman graduated from the Anglo-European College of Chiropractic in Bournemouth, UK with a Masters in Pediatrics.

4. From 2005 to present, Applicant has practiced as a Chiropractor in Westerhope, UK and has no disciplinary action against her license.


5. The evidence presented demonstrates that the United Kingdom of Great Britain maintains standards for chiropractic licensure that are at least equal to those maintained in Kansas.

6. The evidence presented demonstrates that Applicant's original chiropractic license was based on an examination equal in quality to the examination required in Kansas and the passing grade was comparable to the grade required in Kansas.

7. The Board finds that the Applicant has demonstrated satisfactory fulfillment of the requirements of K.S.A. 65-2833 to be granted a license by endorsement to practice chiropractic in the State of Kansas.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant is hereby GRANTED a license by endorsement to practice chiropractic in the State of Kansas.


