FINAL ORDER TERMINATING CONSENT ORDER

NOW, comes before the Kansas State Board of Healing Arts (“Board”), through Presiding Officer Dr. Douglas Milfeld, M.D. (“Presiding Officer”), is the request of William L. Freund, Sr., M.D. (“Licensee”) for the termination of the Consent Order, filed June 19, 2014. Upon consideration of the agency record, including Licensee’s request for termination, and Litigation Counsel’s Response to Licensee’s Request to Terminate (“Response”), the Presiding Officer finds, concludes, and orders as follows:

1. Licensee entered into a Consent Order on June 19, 2014, to resolve [REDACTED]

3. The June 2014 Consent Order is not self terminating. It provides that after a period of five years, Licensee could request modification or termination.

4. On about August 13, 2014, Licensee submitted to the Board documentation evidencing completion of the course *Medical Ethics for Professionals: An Ethics Protection Course* offered by the University of California, Irvine School of Medicine.

5. Licensee has submitted a timely request to terminate the June 2014 Consent Order.

6. On June 21, 2019, Litigation Counsel filed a neutral Response to the request for termination. The Response states the request had not been considered by the Disciplinary Panel for their recommendations.


